

M&M'S® BRAND GET NUTTY SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE CHANCES OF WINNING.

1. **WHO CAN PARTICIPATE (ELIGIBILITY):** This M&M'S® Brand Get Nutty Sweepstakes (“**Sweepstakes**”) is open to individual legal residents of the 50 United States and Washington, D.C., who are age 13 or older as of date of participation.
